

#### WHAT IS TITLE IX?

Title IX is a federal law that prohibits gender and sex-based discrimination including sexual harassment/violence, and pregnancy related discrimination.

## REPORTING TITLE IX ISSUES

Any administrator, supervisor, faculty member, instructor, graduate TA, residential advisor, or other University community member in a position of authority must report any knowledge or complaints of alleged sex-based discrimination to the EOO and relay any request for confidentiality by the complainant.

## WHAT IS THE NDAH POLICY?

The NDAH Policy prohibits discimination and harassment against any member of the UGA community based on protected catgories:

- \* Race
- \* Sex (Including sexual harassment and pregnancy)
- \* Gender Identity
- \* Sexual Orientation
- \* Ethnicity or National Origin
- \* Religion
- \* Age
- \* Genetic Information
- \* Disability Status
- \* Veteran Status

## REPORTING NDAH ISSUES

Any administrator, supervisor, faculty member, instructor, graduate TA, residential advisor, or other University community member in a position of authority must report any knowledge or complaints of alleged discrimination or harassment involving a protected category to the EOO.

### WHAT IS THE ADA?

The ADA provides that no qualified individual with a disability shall, on the basis of the disability, be excluded from participation in or be denied the benefits of the services, programs, or activities of a public entity, or be subjected to discrimination by any public entity. The UGA ADA Coordinator is in the EOO.

## STUDENTS WITH DISABILITIES

The Disability Resource Center (DRC) is available to assist students who know or suspect they may have a disability to help facilitate accommodations.

## SERVICE ANIMALS

Federal law defines "service animal" as "any dog that is individually trained to do work or perform tasks for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual or other mental disability."
